TRADITIONAL WEATHERIZATION FUNDS IN 2017 WERE SUPPLEMENTED BY FUNDS FROM ENERGY ASSISTANCE, PUBLIC BENEFITS AND FEDERAL DEPARTMENT OF ENERGY. THE RESULT WAS A TOTAL OF 261 UNITS WEATHERIZED DURING CALENDAR YEAR 2017.

DURING 2017, COMMUNITY ACTION EFFORTS ALLOWED 101 HOUSEHOLDS TO OBTAIN OR MAINTAIN STABLE HOUSING, AND WE ASSISTED 81 HOMELESS FAMILIES WITH EMERGENCY SHELTER SERVICES.
